| <b>The purposes for which the personal data are to be processed and the legal basis for this:</b>  |
| LBBW processes personal data for the purpose of providing the newsletter on current industry topics and events. The legal basis is Art. 6 (1) (a) GDPR (consent).  |
| <b>Categories of personal data that are processed and sources from which they originate:</b>   |
| For this purpose, LBBW processes the name and contact details, e.g. the (e-mail) address, for sending the newsletter. The data is collected directly from the person.  |
| <b>Recipients or categories of recipients of the personal data:</b>  |
| LBBW only transfers personal data to those entities to which LBBW is required to transfer the data by law.<br><br>Processors employed by LBBW may also receive data for the aforementioned purposes. These are companies in the IT services, logistics, printingservices and telecommunications categories.  |
| <b>the controller's intention to transfer the personal data to a third country or an international organization:</b>   |
| There is no such intention.  |
| <b>The duration for which the personal data will be stored or, if this is not possible, the criteria for determining the duration:</b>   |
| LBBW stores personal data for the period for which consent is given. Once consent has been withdrawn or the purpose no longer applies, the personal data will no longer be stored.   |
| <b>Information as to whether the provision of the personal data is required by law or contract or is necessary for the conclusion of a contract, whether the data subject is obliged to provide the personal data and the possible consequences of non-provision:</b>  |
| The provision of personal data to LBBW is neither legally nor contractually required and is not necessary for the conclusion of a contract. If you do not provide your data, you will not be able to receive newsletters in the future.  |
| <b>Rights of data subjects:</b>  |
| Every data subject has the right of access under Art. 15 GDPR, the right to rectification under Art. 16 GDPR, the right to erasure under Art. 17 GDPR, the right to restriction of processing under Art. 18 GDPR and the right to data portability under Art. 20 GDPR. The restrictions pursuant to Sections 34 and 35 BDSG apply to the right of information and the right to erasure. In addition, you have the right to lodge a complaint with a dataprotection supervisory authority in accordance with Art. 77 GDPR in conjunction with Section 19 BDSG. The data protection supervisory authority responsible for LBBW is the Baden-Württemberg State Commissioner for Data Protection and Freedom of Information. |
| <b>Reference to the existence of a right of withdrawal:</b>  |
| The consenting party has the right to withdraw consent at any time with effect for the future. Withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. In the event of revocation, LBBW will no longer send newsletters to the revoking party. The address to which the revocation should be sent can be found in the respective newsletter.   |
| <b>Information on the existence of automated decision-making including profiling in accordance with Art. 22 (1) and (4) GDPR:</b>  |
