Information on data processing by Landesbank Baden-Württemberg (LBBW) in accordance with Article 13 of the General Data Protection Regulation (GDPR) for image and videorecording.

<p>The purposes for which the personal data are to be processed and the legal basis for this:</p> <p>LBBW processes your personal data for the following purposes, among others:</p> <ul style="list-style-type: none"> • Provision of the recordings for the participants; • Internal image database and image archive; • Use in the internal network (intranet); • Presentation and advertising of our own services; • Information on further and similar events; • for our own print media and comparable publications; • Advertising purposes; • Public reporting on the event; • Public relations; • Use on our website; • Publication in social media; • Passing on images to the press and media; • Commercial use, e.g. in stock image archives; • Photographs and video recordings; • Podcasts; • Management of your consent to the publication of photographs, in particular to record and process your revocation. <p>If we publish your image or video recordings outside our internal intranet, we process your personal data on the basis of consent in accordance with Art. 6 (1) (a) GDPR.</p> <p>When using image and video recordings that are used exclusively on our internal intranet, we process your personal data within the scope of our legitimate interest within the meaning of Art. 6 (1) GDPR. Letter f) GDPR.</p>
<p>Categories of personal data that are processed and sources from which they originate:</p> <p>In addition to your portrait or video recording, we also process the personal data that you have provided to us in your consent or, if applicable, your name, insofar as this is known to us even without obtaining consent.</p> <p>The data is collected directly from you.</p>
<p>Recipients or categories of recipients of the personal data:</p> <p>The personal details and address of the consenting persons and the persons depicted are not transmitted to third parties. The photographs in question are published in accordance with the consent given and can thus be made accessible to an indeterminable group of persons, including abroad.</p> <p>In addition, LBBW uses various service providers as processors. These service providers, in particular from the "IT services and telecommunications" category, may also receive your personal data.</p>
<p>the controller's intention to transfer the personal data to a third country or an international organization:</p> <p>There is no such intention. However, it is possible for employees at our foreign locations to see your image or video if it is published on our internal intranet.</p> <p>The photographs in question are published in accordance with the consent given and can thus be made accessible to an indeterminable group of persons, including abroad.</p>
<p>The duration for which the personal data will be stored or, if this is not possible, the criteria for determining the duration:</p> <p>The images are stored for as long as is necessary for the aforementioned purposes. The image recordings can be stored internally for an unlimited period of time, e.g. to secure legal claims under copyright law by providing evidence of original recordings and also for reasons of historical documentation. In the event of publication, the recordings may be published for as long as the respective publication carriers, articles or contributions are publicly accessible.</p> <p>If we do not obtain your personal data within the scope of consent, we will process your personal data until we receive your objection in accordance with Art. 21 GDPR. If we process your personal data on the basis of your consent, we will also process it until we receive your withdrawal of consent. The circumstances and duration of the declaration of consent and the declaration of consent itself are stored until no further rights can be asserted against the bank on the basis of the consent.</p> <p>LBBW is subject to various retention and documentation obligations arising from the German Commercial Code (HGB), the German Fiscal Code (AO), the German Banking Act (KWG), the German Money Laundering Act (GwG) and foreign trade regulations, among others. The retention and documentation periods specified there are two to ten years. Insofar as it is necessary to store your personal data, we will retain your data for these reasons.</p> <p>Finally, the storage period is also determined by the statutory limitation periods, which, for example, according to Sections 195 et seq. of the German Civil Code (BGB), are generally three years, but in certain cases can be up to thirty years.</p>

Information as to whether the provision of the personal data is required by law or contract or is necessary for the conclusion of a contract, whether the data subject is obliged to provide the personal data and the possible consequences of non-provision:

The provision of personal data is neither legally nor contractually required, nor is it necessary for the conclusion of a contract. There is no obligation to provide . The provision by you is a prerequisite for the photographs to be used to the extent provided for in the consent.

Rights of data subjects:

Every data subject has the right of access under Art. 15 GDPR, the right to rectification under Art. 16 GDPR, the right to erasure under Art. 17 GDPR, the right to restriction of processing under Art. 18 GDPR and the right to data portability under Art. 20 GDPR. The restrictions according to §§ 34 and 35 BDSG apply to the right to information and the right to erasure. In addition, you have the right to lodge a complaint with a data protection supervisory authority in accordance with Art. 77 GDPR in conjunction with § 19 BDSG. The data protection supervisory authority responsible for LBBW is the Baden-Württemberg State Commissioner for Data Protection and Freedom of Information.

Reference to the existence of the right to withdraw consent at any time without affecting the lawfulness of processing based on Art. 6 (1) (a) GDPR or Art. 9 (2) (a) GDPR prior to withdrawal:

The consent given can be revoked at any time with effect for the future. In the event of revocation, LBBW will no longer publish the photographs in question. Any publication already made on the basis of consent cannot, of course, be reversed.

Note, if the processing is based on Art. 6 (1) (f) GDPR, the legitimate interests pursued by the controller or a third party:

LBBW processes the above-mentioned personal data in the overriding interest of providing your employees with an overview of LBBW's various activities and events on the company intranet. The personal data is only accessible to a limited extent and cannot be viewed by everyone. If a person depicted objects, we will remove the images from the intranet.

Information on the existence of automated decision-making including profiling in accordance with Art. 22 (1) and (4) GDPR

There is no automated decision-making or profiling.

Information about your right to object in accordance with Art. 21 GDPR

You have the right to object, on grounds relating to your particular situation, at any time to processing of personal data concerning you which is based on point (f) of Article 6(1) GDPR (data processing on the basis of a balancing of interests).

If you file an objection, we will no longer process your personal data. Unless we can demonstrate compelling legitimate grounds for further processing which override your interests, rights and freedoms or the processing serves the establishment, exercise or defense of legal claims.
