Information on data processing by Landesbank Baden-Württemberg (LBBW) in accordance with Art.

13 of the General Data-Protection Regulation (GDPR) for the use of web conferencing tools in which LBBW processes personal data via.

The purposes for which the personal data are to be processed and the legal basis for this:

If you would like to take part in a virtual customer event, we will send you the relevant information and access data by e-mail as part of the registration process. We process your personal data for the registration process. The legal basis for your participation is therefore yourconsent pursuant to Art. 6 (1) (a) GDPR.

When using a web conferencing tool, your personal data will be processed for the aforementioned purposes for invitation control during the use of the tools and, if applicable, during a recording of the web conference. In order to establish a connection and transfer the video and audio data of the conference to yourference device, we need your IP address. The legal basis for processing for the purpose of holding a web conference is based on a legitimate interest in accordance with Art. 6 para. 1 letterletter f) GDPR or, in the context of the employee relationship, in accordance with Art. 88 in conjunction with. § 26 para. 1 BDSG in order to ensure the functionality of the tool and the security of the web conference to be held. If we plan to record the web conference, you will already be informed of this in the invitation. If you agree, your image and, if applicable, your sound will be recorded as part of such a recording. Before we start the recording, you will receive an acoustic and visual signal. Your voice and image will only be recorded with your consent in accordance with Art. 6 (1) (a) GDPR. We base the other processing operations relating to the recording on our legitimate interest pursuant to Art. 6 (1) (f) GDPR.

If there is a legal obligation to record conversations, the legal basis is Art. 6 (1) (c) GDPR. The call recordings are not stored via and within the web conferencing

We may ask for your feedback at the end of a web conference or initiate a survey. Your responses are processed within the scope of our legitimate interest in data processing pursuant to Art. 6 (1) (f) GDPR.

Recipients or categories of recipients of the personal data:

LBBW uses processors to provide and use a web conferencing tool. It is also possible for us to commission a full-service partner as a service provider to support us in the organization, implementation and follow-up of the web conference. Personal data will not be transmitted to third parties.

the controller's intention to transfer the personal data to a third country or an international organization:

LBBW processes personal data at locations in the EU/EEA. The transfer of personal data beyond this is not intended and will only take place if LBBW has given its prior consent and if an adequate level of data protection is ensured.

The duration for which the personal data will be stored or, if this is not possible, the criteria for determining the duration:

LBBW only stores personal data for as long as the data is required or for as long as it is obliged to do so due to statutory retention periods. Web conference recordings based on consent are stored for 7 days and then deleted.

If LBBW is obliged to store the data due to statutory retention periods, we will store the data until the retention period expires.

Every data subject has the right of access under Art. 15 GDPR, the right to rectification under Art. 16 GDPR, the right to erasure under Art. 17 GDPR, the right to restriction of processing under Art. 18 GDPR and the right to data portability under Art. 20 GDPR. The restrictions under Sections 34 and 35 BDSG apply to the right ofinformation and the right to erasure. In addition, you have the right to lodge a complaint with a dataprotection supervisory authority in accordance with Art 77 GDPR in conjunction with § 19 BDSG. The data protection supervisory authority responsible for LBBW is the Baden-Württemberg State Commissioner for Data Protection and Freedom of Information.

Information as to whether the provision of the personal data is required by law or contract or is necessary for the conclusion of a contract, whether the data subject is obliged to provide the personal data and the possible consequences of non-provision:

The provision of personal data to LBBW is neither required by law nor by contract and is not necessary for the conclusion of a contract. If this is not provided, it may not be possible to participate or hold a web conference.

Reference to the existence of the right to withdraw consent at any time without affecting the lawfulness of processing based on Art. 6 (1) (a) GDPR or Art. 9 (2) (a) GDPR prior to withdrawal:

You have the right to revoke your consent to the storage of recording data at any time with effect for the future. After the withdrawal of consent, LBBW will no longer process the data subject's personal data.

Note, if the processing is based on Art. 6 (1) (f) GDPR, the legitimate interests pursued by the controller or by a third party:

LBBW processes personal data, such as metadata, names and e-mail addresses, in order to ensure the functionality of the web conferencing tool and the security of the data and conversations. The interests of the data subject are safeguarded by ensuring that only as much data is collected as is actually required. Attention tracking does not take place. It is possible to display your video image at any time during the web conference.

Information on the existence of automated decision-making including profiling in accordance with Art. 22 (1) and (4) GDPR:

There is no automated decision-making or profiling.

Information about your right to object in accordance with Art. 21 GDPR

You have the right to object, on grounds relating to your particular situation, at any time to processing of personal data concerning you which is based of Article 6 (1) (f) GDPR (data processing on the basis of a balancing of interests).

If you file an objection, we will no longer process your personal data. Unless we can demonstrate compelling legitimate grounds for further processing which override your interests, rights and freedoms or the processing serves the establishment, exercise or defense of legal claims.
